

## **Consent to Electronic Delivery**

This Notice and Consent Concerning Electronic Signatures and Record (the “Notice and Consent”) contains information about how we will communicate with you and provide you with important information about investment offerings being conducted through FilmCapital.io and Blue Dot Media Holdings (“FilmCapital.io”).
